**Report from S Aquarone (NCCllr)**

I am sad to report, to those that don't already know, the death of Norfolk County Council leader Cliff Jordan this weekend. Despite disagreeing with a great many of Cliff's views, I found him to be a highly committed and authentic person who was prepared to speak out for what he believed was in the interests of Norfolk. He was a true Norfolk character and will be missed by all of us.

As a result of Cliff's resignation just a fortnight before he passed away, Andrew Proctor - until then the leader of Broadland as well as county councillor for Blofield and Brundall - has been elected as leader.

Finally, the County Council appears to have decided to reduce the funding for SEND (Special Educational Needs and Disability) Transport funding. This seems like a low blow: children with special needs will no longer be collected from home and taken to school or college, and will instead have to congregate at bus stops or equivalent. Whilst there will certainly be circumstances where this is totally fine, there will be many young people and their carers for whom this is a cause of great distress. We are campaigning as a group to try and reverse this particularly pernicious cut and would welcome anyone locally who is affected getting in touch with their story.

### 12) Allotments

- a) It was noted that the gate post had been removed and the new fence installed on the boundary by the owners of the property adjacent to the allotment track. A new metal post would be put in and the gate adapted so that it fitted.
- b) A check of the allotments would be done after the next meeting.

### 13) Recreation Ground and Pavilion

- a) **Safety report:** The play area is looking sound no problem with the equipment. The gates are holding out. The main problem is that they haven't always been closed but hopefully with the new signs that have been put up that will improve things.
- b) **Grounds maintenance**
  - i) It was noted that the grass was cut on 14 June.
  - ii) The general appearance of the Rec is quite shocking and it has never looked like this before: the mulch left by Norse (even with the last cut) had made it an area that is difficult and unpleasant to walk on. This has been commented on by many of the Parishioners. Someone has even try to take it up I imagine so their children can play cricket.
  - iii) The weeds were allowed to really establish themselves in the car park before they were sprayed off so no doubt they have seeded themselves everywhere and even if killed look very unsightly I think we need to try and meet Norse on site.
- c) **Waste collection**
  - i) Changed to every 4 weeks (from fortnightly). New invoice to be sent with start date as of 5 June (plus one -off collection). Please note that missed collections need to be reported to Kier on 0300 123 1163 within 7 days of scheduled collection. Next collections due on 3 July, 31 July, 28 August etc.
- d) **New signs** have been purchased and put up
- e) **Disabled friendly path** from The Street to the Pavilion: progress report
  - i) Application for funding submitted to NNDC Big Society Fund - next panel is in September.
- f) **Goal posts:** It was noted that Chip Davison and Trevor Leeder would help Peter Patten to erect them.
- g) It was agreed that Trevor Leeder and Wayne Jolly would mark out the footings for the MUGA and get them signed off by NNDC
- h) Request from **Longham FC** to rent the pitches and pavilion next season. They had not contacted the Clerk or the Chair following the last communication. The Clerk was asked to contact them again to clarify the situation. It was noted that Peter Patten was happy to mark out the pitch if required.
