#### Public Forum

Welcome from the Chair

- Members of the public may raise matters of concern and make comments in respect of items on the Agenda before the Parish Council meeting opens.
  - A member of the public raised an issue regarding the land at the Dyes. It was hoped that the Parish Council land of 3.5 acres could be identified properly. A map was supplied from Savills which provided an outline of the area. A land registry search had also been carried out. It was noted that the tenant had said that he would write to the Parish Council about this. It was hoped that this would sufficient clarity for the land to be registered.
  - A member of the public asked about the land that had been fenced on the Fulmodeston Road. The Chair explained that this was being managed for nature and the environment by the Felbeck Trust. - c) Other planning matters
  - i) It was agreed to support a request from Bintree Parish Council in their campaign against a proposal for a new town of 5,000 houses on an area of fertile agricultural land enveloping Bintree, Billingford and North Elmham. They have great concern about the detrimental impact that such a development would have on the River Wensum, access, transport, local character and food security etc. Breckland District Council has already granted 14,061 household permissions (80% of the district's requirement through to 2046 (the remaining 20% will be more than covered by the natural flow of small developments). The campaigners wish to present to Breckland DC a list of local Councils that are against the proposal to site a new town between Elmham, Billingford and Bintree.
  - ii) Complaints about **Bridge End**. The planning officer at the County Council has visited the site, reviewed the approved documents, the decision notice and discussed the site & the concerns with colleagues. The approved site plan defines the site car parking area (without demarcated parking spaces), at the time of his visit all the cars associated with the Children's Home were parked within the car parking area. He counted eight cars parked in this area, this differs from the figure of five which the applicant quoted in the planning application form. That said, there's not a condition limiting the number of vehicles that can park at the site in the decision notice, however, he will contact the applicant to discuss this issue in more detail. Aside from the car parking issue, there didn't appear to be

any breaches of planning control at the site at the time of my visit. He will continue to monitor the site.

- iii) It was also noted that information had been received that residents of the Ashcroft Barns regular park on the side of the road which makes it very difficult for road users. The Clerk was asked to bring this to the attention of the planning department at North Norfolk District Council as it might be in breach of the planning consent.
