### 12) Recreation Ground and Pavilion

- a) **Nature Reserve** at bottom of Rec.
  - i) It was noted that the water carrier has been received. It is being stored in the shower of the Pavilion, pending the erection of the shed. Thank you to all those who are helping with the watering.
  - ii) Tree guards how many and what sort are required? Not necessary at the moment.
  - iii) Four notices for the entrance etc have been made by Steward Safety Supplies: 'Hindolveston Nature Reserve No Dogs [pictogram] except assistance dogs'
  - iv) Ryan has quoted £35 to strim a two foot path around the area. This was approved and it was agreed to ask him to widen the entrance so that a ride-on can get through.
- b) Regular check of equipment: no problems with equipment. However it was noted that glass and vaping rubbish was found on the field. It was agreed to inform the police and ask them to include the Recreation Ground on the rounds.
- c) Grounds maintenance.
  - i) Complaints have been received about the grass cutting this season. The Chair had phoned CGM but had difficulty speaking to the manager. She managed to speak
